A Greener World's Certified Regenerative programme is unique. You will create a Regenerative Plan for your entire holding, which will make up the core of your certification. While we recognise the competency of many farmers to write their own Regenerative Plan, you may benefit from the services of a Qualified Expert to help you develop your plan, or for specific areas that you don't feel comfortable with – for example, bringing in an expert to do a bird count or for soil health advice. Please ensure the person you choose has the skills to support you in writing your plan.
